



Nursery Hours

8.45am – 12.45 / 2.45pm
Lunch is between 11.45am – 12:45pm

We aspire to create a happy, relaxed atmosphere in our nursery class. Please help us to achieve this by always entering the nursery calmly during transition times at the start and end of sessions.

Our doors open at 8:45 each morning. If you need to pass on any relevant information regarding your child e.g. If they are tired due to a sleepless night, or any other factor that might affect their learning that day, please speak to a member of the nursery team. At the end of the session, it is important to collect your child promptly as they can become anxious if everyone else has gone and they are left alone. Due to our safeguarding policy, please ensure the nursery staff know who is picking up your child at home time. If a different person to normal is coming to school to collect, please notify the school secretary. Older brothers and sisters are not considered sufficiently responsible to collect children from nursery.

Registration of nursery places

Please contact our school secretary or collect a form from school to register a new child for Nursery. It is advisable to do this as early as possible.

Admissions Policy

- Prospective parents and their child/children are requested to make an appointment to visit the school.
- Places will be allocated according to CYPES criteria.
- From September 2021, funded hours of Nursery education for all children aged 3 to 4 years increased from 20 to 30 hours per week.
- The full 30 hours are there for all children to access when they are ready for them.

A place in St. John's School Nursery does not guarantee a place in the Reception class the following year. For current Reception procedures for admission, please visit www.gov.je





Aims and Objectives of our Nursery

Our setting aims to provide:

- A caring environment.
- Opportunities to 'have a go' without fear of failure.
- A safe place where we are all recognised as a unique individual.
- An environment where we are listened to and valued.
- A place where self-esteem is given a high priority.
- Positive opportunities for all children, regardless of gender, ethnic origin or social circumstance.

Our nursery is a place where we give time and space for the children to discover the world around them. We value the importance of treating children as individuals and embrace their learning styles. The adults in our setting tune into children's interests to facilitate quality reflective learning experiences.

We place great priority on building quality, secure relationships between adults and children. Learning opportunities initiated by children will be used to provide a platform to model a dialogue of enquiry and provoke curiosity. This is achieved by displaying a genuine interest, giving encouragement, welcoming and clarifying ideas and asking open questions to support and extend the children's thinking and helping them to make connections in their learning.

Development Matters

The Framework for EYFS published in 2021 underpins our nursery practice. The guidance has a strong emphasis on play being the most effective medium for young children's exploration and learning. The fundamental purpose of our planning is to tune into the needs of our individual children using the guidance in 'Birth to Five Matters and Development Matters 2021 version.

We observe your children's development and achievements in order to best support them on their Learning Journey. We work in partnership between home and nursery and value parental contributions.

The Nursery team work extremely hard to build secure, happy, positive relationships with each child.

During the day the children have the opportunity for playing and learning in small groups and also to engage in circle time learning. During these focused times, all areas of the curriculum may be visited. The Nursery Staff are always willing to discuss and answer any questions about your child's experiences.

The ethos of the school, **Thinking, Learning and Caring** is a sentiment at the very 'heart' of our nursery. In our attempt to fulfil this mission statement we facilitate continuous provision opportunities and aim to. . .

- Give children time/space to experiment with any existing skills/knowledge they already have.
- Help children to discover things for themselves and most importantly see obstacles as part of their learning.
- Work alongside each child to test theories, make suggestions and reflect.
- Provide resources to support independent learning.
- Use the language and vocabulary of thinking.
- Give praise and value to children's efforts, suggestions and successes.
- Allow children to develop a 'can do' attitude by taking risks, to move out of their comfort zone in a safe environment.
- Model resilience, thoughtfulness and willingness to listen to the ideas and opinions of others, to make mistakes and learn from them.

The curriculum provides opportunities to develop the children's conceptual thinking in Prime and Specific areas. This is in line with the Early Learning Goals set in the Foundation Stage of the Jersey Early Years Curriculum.





Contributions

We ask for a nursery contribution to cover costs such as snack, cooking, outdoor activities and to enhance any extra projects that the children take an interest in. Snack is provided every day and is usually a cup of milk/water with something savoury such as cheese and biscuits followed by fresh fruit, but we also try to introduce the children to many new tastes during the year, including cuisine from other countries. We do not allow sweets, chocolate, or fizzy drinks to be brought into Nursery.

At the beginning of each term, we make a request for payment. We ask for a cheque to be made payable termly in advance to St Johns School Nursery. The amount is £60 per term for each child.

Lunchtime Provision

Children will be required to bring a packed lunch in a named lunch box. Nutritious ideas could consist of a sandwich or pasta, fruit or yoghurt and/or a biscuit or small cake etc. Children will also need a named bottle of water which they can access throughout the day to stay hydrated.

Toilet Training

We would hope that children starting Nursery are on the journey to being toilet trained and learning to use the toilet independently with encouragement. Should you require support in this area please do not hesitate to contact the Nursery Team. In addition, as a parent or carer, you can contact your Health Visitor for advice in advance of your child starting Nursery.

Please try to ensure that the clothes your child wears to Nursery are loose fitting and easy for them to remove and fasten again. If a child has an accident, we do have a limited stock of clothing that can be worn home, however, please try and return these as soon as possible. We find it helpful if you can provide a drawstring bag of spare clothes for your child which can be left on their peg.

Clothing

Practical, comfortable clothes that are suitable for painting, water play, and outdoor learning are best for attending Nursery. We do provide aprons for messy activities, but accidents do happen. We do go out in all weather and with this in mind, your child will therefore need a suitable named waterproof coat for the winter months, a pair of named Wellingtons to leave at school if possible and a named bicycle helmet that fits your child. All in one waterproof dungarees are also useful.

Please do not allow your child to wear jewellery as this can be dangerous and can cause distress if it breaks or gets lost.

During the summer term, it is advisable that the children have a sun hat and are wearing an all-day sunscreen on sunny days for outdoor activities. We recommend children have covered shoulders and wear closed toe sandals or shoes for safety.





Starting Nursery

Starting Nursery is a big step for children and parents! We want to make your child's Learning Journey a happy one and do all we can to provide a positive, secure environment. In the early days, we ask that you settle your child in preparation for the beginning of the session. Please always say goodbye and reassure them that you will be returning at the end of the Nursery session. We have a waving window that the children love to use as part of this routine. The Nursery team will support children and carers during this transition time.

How can you help at home?

You can help at home by giving your child a wide range of experiences, which prepare them for nursery:

- Encourage your child to use the toilet independently, dress and undress, including doing up buttons, buckles and zips.
- Teach your child to put away all toys and books after playing with them.
- Give your child opportunities to play and share with other children.
- Ensure that your child has opportunities to develop listening skills.
- Learn songs and nursery rhymes and sing them together.
- Encourage your child to make marks, use scissors safely, play with playdough, construction toys, dress up, help with cooking etc.
- Talk about some of the exciting things that they will be able to do in Nursery, such as going out on trips on the mini-bus, riding bikes, gardening, singing and learning outdoors.
- Make special time to share books with your child and talk about everyday events.
- Encourage lots of physical outdoor experiences.
- Above all, help your child to become **INDEPENDENT** as early as possible.

Parental Help

We encourage parents to join us to support our nursery class visits. We promote a home school partnership and encourage active involvement in learning initiatives. Parents will also be invited to attend various events to celebrate the learning of the children.

Illness

If your child is ill, on any medication or suffering from an infection that may be passed on to another child, please keep them at home and let us know as soon as possible either by telephone 861692 or by emailing to admin@stjohn.sch.je and your message will be forwarded on to the Nursery Team. Education Department policy states that children who have highly infectious conditions such as diarrhoea and vomiting must stay at home for 48 hours after the last symptoms.

Inhalers for asthmatic conditions must be labelled and school procedures for completing a medical form followed. If your child needs ongoing medication, please talk the issue through with the staff and a care plan will be put in place. When your child starts in Nursery and at any other subsequent time you must inform us of any medical condition.

Students and Volunteers

We often host student childcare practitioners who are in training. They usually take photographs and make written observations of children. They always change the names in their reports and their work remains confidential between themselves and their tutors. If you have any reservations about this please talk to the Nursery team.

Parking

The playground and parking areas outside the school are very busy at both the beginning and end of the day, therefore, it is vital that an adult holds the hand of the child in order to keep everyone safe. The School can be

entered by using the side gate adjacent to the Parish hall. You can then access the nursery by walking along the perimeter pathway of the playground, round to the side EYFS Nursery entrance.

The climbing equipment in the main school playground should not be accessed at any time.

Safeguarding and Child Protection

Keeping children safe is an integral part of what we do in school. We follow the CYPES Safeguarding and Child Protection policies and national guidelines. Should we suspect any form of neglect, physical, sexual or emotional abuse is occurring to any individuals in our care, we will report this to the Children and Families Hub. Information about this service is available on the gov.je website.

Please see the poster shown below for the named Designated Safeguarding Leads.

All staff employed within the school have received Safeguarding and Child Protection training and their DBS (police) checks are in place. Your child's safety is our utmost concern. You will usually be contacted with any concerns that we may have in the case of a referral, unless we and the Children's Service believe that this will be against the interests of your child.

If you wish to help the school with reading, visits etc, on a regular basis, then please consider asking for information to complete the DBS process at the school office. All adults in regular contact with the children need to go through this process for the safety and wellbeing of the children.

Parental Responsibility (PR)

Parental responsibility is about making decisions which affect a child's welfare and the people who are legally able to do this. A person with parental responsibility for a child will have certain rights, powers and authority, duties and responsibilities. Below we outline the laws around PR:

What does Parental Responsibility include?

- ✓ where the child should live
- ✓ the child's education
- ✓ applying for a passport
- ✓ significant movement of the child such as:
 - ✓ leaving the country for a holiday
 - ✓ leaving the jurisdiction (emigrating)
- ✓ the child's name (including changes to name by Deed Poll)
- ✓ protecting the child
- ✓ the child's religious upbringing
- ✓ consent to the child's medical treatment
- ✓ consent to freeing the child for adoption
- ✓ looking after the child's property (e.g. inheritance)
- ✓ the child's burial or cremation

Who has Parental Responsibility for a child?

- ✓ The mother of the child will automatically have parental responsibility for her child.
- ✓ If the father was married to the mother of the child at the time of the child's birth and registered as the father on the birth certificate, he will also have parental responsibility for his child.
- ✓ Someone else can have parental responsibility for a child if either:
 - ✓ a custody order or a residence order has been made in their favour
 - ✓ they have responsibility for the child under an emergency protection order
 - ✓ they are a guardian of the child
 - ✓ they have adopted the child

Do unmarried Fathers have Parental Responsibility?

If your child was born **before 2nd December** 2016:

For births registered in Jersey before 2nd December 2016, an unmarried father will **not** have automatic parental responsibility for his child even if he is registered on the birth certificate. In order to acquire parental responsibility, an unmarried father must enter into a parental responsibility agreement with the child's mother or apply to the court for a parental responsibility order.

If your child was born **on or after 2nd December** 2016:

If the father of the child is not married to the mother at the time of the child's birth but is registered on the birth certificate, the father will automatically have parental responsibility for his child.

Birth Certificate/Identity Card.

It is a requirement by the Department for CYPES that the school records it has seen your child's birth certificate. Once we have seen this, we will record this on our central administration system (SIMS).

This will clarify for the school who has PR for your child. This means that the school can fulfil its data protection (GDPR) responsibilities for your child. All new families to the school will be asked to bring their child's birth certificate to the school office for processing.
